# CROSSING LIMIT CYCLES FOR A CLASS OF PIECEWISE LINEAR DIFFERENTIAL CENTERS SEPARATED BY A CONIC

#### Abstract

These last years the study of the version of Hilbert's 16th problem for piecewise linear differential systems in the plane, has increased strongly and there are many papers studying the maximum number of crossing limit cycles when the differential system is defined in two zones separated by a straight line, in particular in [11, 13] it was proved that piecewise linear differential centers separated by a straight line have no crossing limit cycles, but in the papers $[14,15]$ it was shown that the maximum number of crossing limit cycles of piecewise linear differential centers, can change depending of the shape of the discontinuity curve. In this work we study the maximum number of crossing limit cycles of piecewise linear differential centers separated by a conic.


## 1. Introduction and statement of the main Results

The study of the discontinuous piecewise linear differential systems in the plane started with Andronov, Vitt and Khaikin in [1], and after these systems have been a topic of great interest in the mathematical community due to their applications in various areas, because they are used for modeling real phenomena and different modern devices, see for instance the books $[4,21]$ and references quoted therein.

In the qualitative theory of differential systems in the plane a limit cycle is a periodic orbit which is isolated in the set of all periodic orbits of the system. This concept was defined by Poincaré $[17,18]$. In several papers as $[3,10,22]$ it was shown that the limits cycles model many phenomena of the real world. After these works the non-existence, existence, the maximum number and other properties of the limit cycles were extensively studied by mathematicians and physicists and more recently, by biologists, economist and engineers, see for instance [4, 23].

As for the general case of planar differential systems one of the main problems for the particular case of the piecewise linear differential centers is to determine the existence and the maximum number of crossing limits cycles that these systems can exhibit. In this paper we study the crossing limit cycles which are periodic orbits isolated in the set of all periodic orbits of the piecewise linear differential centers, which only have isolated points of intersection with the discontinuity curve.

To establish an upper bound for the number of crossing limit cycles for the family of piecewise linear differential systems in the plane separated by a straight line has been the subject of many recent papers, see for instance [2, 5, 7, 20]. In 1990 Lum and Chua [16] conjectured that the continuous piecewise linear systems in the plane separated by one straight line have at most one limit cycle, in 1998 this conjecture was proved by Freire et al [6]. Afterwards in 2010 Han and Zhang [8] conjectured that discontinuous piecewise linear differential systems in the plane separated by a straight line have at most two crossing limit cycles but in 2012 Huan and Yang [9] gave a negative answer to this conjecture through a numerical example with three crossing limit cycles, later on Llibre and Ponce in [12] proved

[^0]the existence of these three limit cycles analytically, but it is still an open problem to know if 3 is the maximum number of crossing limit cycles that this class of systems can have.

In the paper [11] it was extended the problem of Lum and Chua to the class of discontinuous piecewise linear differential systems in the plane separated by a straight line, in particular it was proved that the class of planar discontinuous piecewise linear differential centers, has no crossing limit cycles. However, recently in [14, 15] were studied planar discontinuous piecewise linear differential centers where the curve of discontinuity is not a straight line, and it was shown that the number of crossing limit cycles in these systems is non-zero. For this reason it is interesting to study the role which plays the shape of the discontinuity curve in the number of crossing limit cycles that planar discontinuous piecewise linear differential centers can have.

In this paper we provide an upper bound for the maximum number of crossing limit cycles of the planar discontinuous piecewise linear differential centers separated by a conic $\Sigma$.

Using an affine change of coordinates, any conic can be written in one following nine canonical forms:
$(\mathrm{p}): x^{2}+y^{2}=0$ two complex straight lines intersecting at a real point; (CL): $x^{2}+1=0$ two complex parallel straight lines; (CE): $x^{2}+y^{2}+1=0$ complex ellipse; (DL): $x^{2}=0$ one double real straight line; (PL): $x^{2}-1=0$ two real parallel straight lines; (LV): $x y=0$ two real straight lines intersecting at a real point; (E): $x^{2}+y^{2}-1=0$ ellipse; (H): $x^{2}-y^{2}-1=0$, hyperbola; $(\mathrm{P}): y-x^{2}=0$ parabola.

We do not consider conics of type (p), (CL) or (CE) because they do not separate the plane in connected regions.

We observe that we have two options for crossing limit cycles of discontinuous piecewise linear differential centers separated by a conic $\Sigma$, first we have the crossing limit cycles such that intersect the discontinuity curve in exactly two points and second we have the crossing limit cycles such that intersect the discontinuity curve $\Sigma$ in four points, we study these two cases in the following sections.
1.1. Crossing limit cycles intersecting the discontinuity curve $\Sigma$ in two points. The maximum number of crossing limit cycles of piecewise linear differential centers separated by a conic $\Sigma$ such that intersect $\Sigma$ in exactly two points is given in the following theorems

Theorem 1. Consider a planar discontinuous piecewise linear differential centers where $\Sigma$ is a conic. If $\Sigma$ is of the type
(a) $(L V),(P L)$ or $(D L)$, then there are no crossing limit cycles.
(b) (E), then the maximum number of crossing limit cycles intersecting $\Sigma$ in two points is two.
(a) $(P)$, then the maximum number of crossing limit cycles intersecting $\Sigma$ in two points is three.

Theorem 1 is proved in section 2.
In the cases studied up to now, there is no a result determining the maximum number of crossing limit cycles for discontinuous piecewise linear differential centers when $\Sigma$ is a hyperbola (H), we determine it in the following Theorem

Theorem 2. Consider $\mathcal{F}_{0}$ the family of planar discontinuous piecewise linear differential centers where $\Sigma$ is a hyperbola (H). Then the following statement hold.
(a) There are systems in $\mathcal{F}_{0}$ without crossing limit cycles.
(b) There are systems in $\mathcal{F}_{0}$ having exactly one crossing limit cycle that intersects $\Sigma$ in two points, see Figure 3.
(c) There are systems in $\mathcal{F}_{0}$ having exactly two crossing limit cycles that intersect $\Sigma$ in two points, see Figure 4.
(d) For this family of systems $\mathcal{F}_{0}$ we have that the maximum number of crossing limit cycles that intersect $\Sigma$ in two points is two.

Theorem 2 is proved in section 3.
1.2. Crossing limit cycles intersecting the discontinuity curve $\Sigma$ in four points. Here we do not consider the case where the discontinuity curve is the conic (DL), because first in $[11,13]$ it was proved that discontinuous piecewise linear differential systems separated by a straight line have no crossing limit cycles and second because the crossing limit cycles of these discontinuous piecewise linear centers cannot have four points on the discontinuity curve.

In the following theorems we analyze the maximum number of crossing limit cycles for planar discontinuous piecewise linear differential centers with four points on discontinuity curve, where the plane is divided by the curve of discontinuity $\Sigma \in\{(P L),(L V),(P),(E),(H)\}$.

Theorem 3. Let $\mathcal{F}_{1}$ be the family of planar discontinuous piecewise linear differential systems formed by three linear centers and with $\Sigma$ of type ( $P L$ ). Then for this family the maximum number of crossing limit cycles that intersect $\Sigma$ in four points is one. Moreover there are systems in this class having one crossing limit cycle.

Theorem 3 for a particular linear center between the two parallel straight lines was done in [13], in section 4 we prove it for any linear center.

If the discontinuity curve $\Sigma$ is of the type (LV), then we have the following regions in the plane: $R_{1}=\left\{(x, y) \in \mathbb{R}^{2}: x>0\right.$ and $\left.y>0\right\}, R_{2}=\left\{(x, y) \in \mathbb{R}^{2}: x<0\right.$ and $\left.y>0\right\}$, $R_{3}=\left\{(x, y) \in \mathbb{R}^{2}: x<0\right.$ and $\left.y<0\right\}$ and $R_{4}=\left\{(x, y) \in \mathbb{R}^{2}: x>0\right.$ and $\left.y<0\right\}$. Moreover, $\Sigma=\Gamma_{1}^{+} \cup \Gamma_{1}^{-} \cup \Gamma_{2}^{+} \cup \Gamma_{2}^{-}$, where $\Gamma_{1}^{+}=\left\{(x, y) \in \mathbb{R}^{2}: x=0, y \geq 0\right\}, \Gamma_{1}^{-}=\left\{(x, y) \in \mathbb{R}^{2}: x=\right.$ $0, y \leq 0\}, \Gamma_{2}^{+}=\left\{(x, y) \in \mathbb{R}^{2}: y=0, x \geq 0\right\}$ and $\Gamma_{2}^{-}=\left\{(x, y) \in \mathbb{R}^{2}: y=0, x \leq 0\right\}$. In this case we have two types of crossing limit cycles, namely crossing limit cycles of type 1 which intersect only two branches of $\Sigma$ in exactly two points in each branch, and crossing limit cycles of type 2 which intersect in a unique point each branch of the set $\Sigma$.

Theorem 4. Let $\mathcal{F}_{2}$ be the family of planar discontinuous piecewise linear differential systems formed by four linear centers and with $\Sigma$ of the type ( $L V$ ). The maximum number of crossing limit cycles type 1 is one. Moreover there are systems in this class having one crossing limit cycle.

Theorem 4 is proved in Section 5.
Theorem 5. Consider the family of planar discontinuous piecewise linear differential centers $\mathcal{F}_{2}$. Then the following statement hold.
(a) There are systems in $\mathcal{F}_{2}$ with exactly one crossing limit cycle of type 2, see Figure 8.
(b) There are systems in $\mathcal{F}_{2}$ with exactly two crossing limit cycles of type 2 , see Figure 9.
(c) There are systems in $\mathcal{F}_{2}$ with exactly three crossing limit cycles of type 2 , see Figure 10

Theorem 5 is proved in Section 6.

By the calculations made for this case and the illustrated examples in Theorem 5 we get the following conjecture.

Conjecture 1. For the family of systems $\mathcal{F}_{2}$ the maximum number of crossing limit cycles of type 2 is three.

Theorem 6. Let $\mathcal{F}_{3}$ be the family of planar discontinuous piecewise linear differential systems formed by two linear centers and with $\Sigma$ of type ( $P$ ). Then for this family the maximum number of crossing limit cycles that intersect $\Sigma$ in four points is one. Moreover there are systems in this class having one crossing limit cycle.

Theorem 6 is proved in Section 7.
Theorem 7. Let $\mathcal{F}_{4}$ be the family of planar discontinuous piecewise linear differential systems formed by two linear centers and with $\Sigma$ of type ( $E$ ). Then for this family the maximum number of crossing limit cycles that intersect $\Sigma$ in four points is one. Moreover there are systems in this class having one crossing limit cycle.

Theorem 7 is proved in Section 8.
Theorem 8. Let $\mathcal{F}_{5}$ be the family of planar discontinuous piecewise linear differential systems formed by three linear centers and with $\Sigma$ of type ( $H$ ). Then for this family the maximum number of crossing limit cycles that intersect $\Sigma$ in four points is one. Moreover there are systems in this class having one crossing limit cycle.

Theorem 8 is proved in Section 9.
1.3. Crossing limit cycles with four and with two points on the discontinuity curve $\Sigma$ simultaneously. Here we study the maximum number of crossing limit cycles of planar discontinuous piecewise linear differential centers that intersect the discontinuity curve $\Sigma$ in two and in four points simultaneously.

We do not consider planar discontinuous piecewise linear differential centers with discontinuity curve a conic of type (DL), (PL) and (LV) because as in the proof of Theorem 1 they do not have crossing limit cycles that intersect the discontinuity curve in two points. Then we study the maximum number of crossing limit cycles with two and with four points in $\Sigma$ simultaneously by the families $\mathcal{F}_{3}, \mathcal{F}_{4}$ and $\mathcal{F}_{5}$.

Theorem 9. The following statements hold.
(a) The planar discontinuous piecewise linear differential centers that belong to the family $\mathcal{F}_{3}$, can have simultaneous one crossing limit cycle that intersects $(P)$ in two points and one crossing limit cycle that intersects $(P)$ in four points.
(b) The planar discontinuous piecewise linear differential centers that belong to the family $\mathcal{F}_{4}$, can have simultaneous one crossing limit cycle that intersects ( $E$ ) in two points and one crossing limit cycle that intersects ( $E$ ) in four points.
(c) The planar discontinuous piecewise linear differential centers that belong to the family $\mathcal{F}_{5}$, can have simultaneous one crossing limit cycle that intersects ( $H$ ) in two points and one crossing limit cycle that intersects (H) in four points.

Theorem 9 is proved in Section 10 .
In Subsection 1.3 we do not consider the planar discontinuous piecewise linear differential centers in the family $\mathcal{F}_{2}$, because they do not have crossing limit cycles that intersect the discontinuity curve (LV) in two points. However in this family there are two types of crossing limit cycles like it was defined in Subsection 1.2.
1.4. Crossing limit cycles of types 1 and 2 simultaneously for planar discontinuous piecewise linear differential centers in $\mathcal{F}_{2}$. In this case we study the maximum number of crossing limit cycles of types 1 and 2 that planar discontinuous piecewise linear differential centers in the family $\mathcal{F}_{2}$ can have simultaneously.

Theorem 10. The following statements hold.
(a) There are planar discontinuous piecewise linear differential centers that belong to the family $\mathcal{F}_{2}$ such that have one crossing limit cycle of type 1 and one crossing limit cycle of type 2 simultaneously.
(b) There are planar discontinuous piecewise linear differential centers that belong to the family $\mathcal{F}_{2}$ such that have one crossing limit cycle of type 1 and two crossing limit cycles of type 2 simultaneously.

Theorem 10 is proved in Section 11.
By the illustrated examples in Theorem 10 we get the following conjecture.
Conjecture 2. The planar discontinuous piecewise linear differential centers that belong to the family $\mathcal{F}_{2}$ can have at most one crossing limit cycle of type 1 and two crossing limit cycles of type 2 simultaneously.

## 2. Proof of Theorem 1

Analyzing the case of discontinuous piecewise linear differential centers with discontinuity curve a conic of the type (LV), (PL) or (DL) the maximum number of crossing limit cycles is equal to the maximum number of crossing limit cycles in discontinuous piecewise linear differential centers in the plane separated by a single straight line which was studied in [11, 13]. In these papers it was proved that the discontinuous piecewise linear differential centers separated by one straight line have no crossing limit cycles. This proves the statement (a) of Theorem 1.

In the paper [15] the authors considered discontinuous piecewise linear differential centers separated by the parabola $y=x^{2}$ and proved that they have at most three crossing limit cycles that intersect $\Sigma$ in two points, i.e. statement (b) of Theorem 1. Moreover they provide the following system.


Figure 1. The three limit cycles of the discontinuous piecewise linear differential of Example 1.

Example 1. Consider the discontinuous piecewise linear differential system in $\mathbb{R}^{2}$ separated by the parabola $(P)$ when both linear differential systems are centers and are defined as
follows:

$$
\begin{gathered}
\dot{x}=-\frac{18}{5}-y, \quad \dot{y}=x-\frac{99}{50}, \quad \text { in } R_{1}=\left\{(x, y): y \geq x^{2}\right\} \\
\dot{x}=-\frac{189}{100} x+\frac{38221}{20500} y-\frac{720042289}{205000000}, \dot{y}=-\frac{41}{20} x+\frac{189}{100} y-\frac{3296401}{1000000}, \text { in } R_{2}=\left\{(x, y): y \leq x^{2}\right\} .
\end{gathered}
$$

This discontinuous piecewise linear differential system has the three crossing limit cycles of Figure 1.

With regard to the discontinuous piecewise linear differential systems separated by an ellipse, in the paper [14] the authors shown that the class of planar discontinuous piecewise linear differential centers separated by the circle $\mathbb{S}^{1}$ has at most two crossing limit cycles. Moreover, there are discontinuous piecewise linear differential centers which reach the upper bound of 2 crossing limit cycles, see Example 2. Then we have the statement (c) of Theorem 1.

Example 2. We consider the discontinuous piecewise linear differential system in $\mathbb{R}^{2}$ separated by the ellipse (E) and both linear differential centers are defined as follows:

$$
\dot{x}=-2 x-2 y-\sqrt{2}-1, \quad \dot{y}=4 x+2 y+\sqrt{2}
$$

in the unbounded region limited by the ellipse ( $E$ ), and in the bounded region with boundary the ellipse ( $E$ ) we have the linear differential center

$$
\dot{x}=x-\frac{5}{4} y+\frac{1}{\sqrt{2}}+\frac{1}{8}, \quad \dot{y}=x-y-\frac{1}{\sqrt{2}} .
$$

This discontinuous piecewise differential system has exactly two crossing limit cycles, see Figure 2.


Figure 2. The two limit cycles of the discontinuous piecewise linear differential of Example 2.

## 3. Proof of Theorem 2

For the systems of the class $\mathcal{F}_{0}$ we have following regions in the plane

$$
R_{1}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}-y^{2}>1\right\}
$$

which is a region that consist of two connected components. And the region

$$
R_{2}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}-y^{2}<1\right\} .
$$

In order to have a crossing limit cycle, which intersects the hyperbola $x^{2}-y^{2}=1$ in two different points $p=\left(x_{1}, y_{1}\right)$ and $q=\left(x_{2}, y_{2}\right)$, these points must satisfy the closing equations

$$
\begin{align*}
H_{1}\left(x_{1}, y_{1}\right) & =H_{1}\left(x_{2}, y_{2}\right) \\
H_{2}\left(x_{2}, y_{2}\right) & =H_{2}\left(x_{1}, y_{1}\right) \\
x_{1}^{2}-y_{1}^{2} & =1  \tag{1}\\
x_{2}^{2}-y_{2}^{2} & =1
\end{align*}
$$

Proof of statement (a) of Theorem 2. We consider a discontinuous piecewise linear differential system which has the linear center

$$
\begin{equation*}
\dot{x}=-y, \quad \dot{y}=x \tag{2}
\end{equation*}
$$

in the region $R_{2}$, the orbits of this center intersect the hyperbola in two or in four points, when it intersects the hyperbola in exactly two points these are $( \pm 1,0)$, which are points of tangency between the hyperbola and the solution curves of the center (2), then it is impossible that there are crossing periodic orbits independent of the linear differential center that can be considered in the region $R_{1}$. So the orbits which can produce a crossing limit cycle intersect the hyperbola in four points and clearly these orbits cannot be crossing limit cycles with exactly two points on the discontinuity curve (H).

Proof of statement (b) of Theorem 2. In the region $R_{1}$ we consider the linear differential center

$$
\begin{equation*}
\dot{x}=27-\sqrt{5}-25 y, \quad \dot{y}=-2+x \tag{3}
\end{equation*}
$$

this system has the first integral $H_{1}(x, y)=4(-4+x) x+4 y(-54+2 \sqrt{5}+25 y)$. In the region $R_{2}$ we have the linear differential center

$$
\begin{equation*}
\dot{x}=2-\frac{3 \sqrt{5}}{4}-\frac{y}{4}, \quad \dot{y}=-\frac{3}{2}+x \tag{4}
\end{equation*}
$$

which has the first integral $H_{2}(x, y)=4(-3+x) x+y(-16+6 \sqrt{5}+y)$. This discontinuous


Figure 3. The crossing limit cycle of the discontinuous piecewise linear differential system formed by the centers (3) and (4).
piecewise differential system formed by the linear differential centers (3) and (4) has one crossing limit cycle, because the unique real solution $(p, q)$ with $p \neq q$ of the closing equations given in (1), is $p=(1,0)$ and $q=(\sqrt{5}, 2)$. See the crossing limit cycle of this system in Figure 3.

Proof of statement (c) of Theorem 2. In the region $R_{1}$ we consider the linear differential center

$$
\dot{x}=\frac{289-48 \sqrt{2}+289 \sqrt{3}-305 \sqrt{6}}{768}+\frac{x}{8 \sqrt{3}}-\frac{49}{192} y,
$$

$$
\begin{equation*}
\dot{y}=\frac{(32 \sqrt{3}-289 \sqrt{2})(1+\sqrt{2+\sqrt{3}})}{768}+x-\frac{y}{8 \sqrt{3}}, \tag{5}
\end{equation*}
$$

which has the first integral

$$
\begin{aligned}
H_{1}(x, y)= & \frac{1}{96}\left(384 x^{2}+x((32 \sqrt{3}-289 \sqrt{2})(1+\sqrt{2+\sqrt{3}})-32 \sqrt{3} y)\right. \\
& +y(98 y-\sqrt{3(85057-9248 \sqrt{6})}+305 \sqrt{6}-289))
\end{aligned}
$$

In the region $R_{2}$ we have the linear differential center

$$
\begin{equation*}
\dot{x}=\frac{1}{8}(-3+8 \sqrt{2}+\sqrt{3}-\sqrt{6})-\frac{x}{2}-\frac{y}{2}, \quad \dot{y}=\frac{1}{8}(-1-5 \sqrt{2}-\sqrt{3})+x+\frac{y}{2} \tag{6}
\end{equation*}
$$

this system has the first integral

$$
H_{2}(x, y)=4 x^{2}-x(1+5 \sqrt{2}+\sqrt{3}-4 y)+y(3-8 \sqrt{2}-\sqrt{3}+\sqrt{6}+2 y) .
$$

This discontinuous piecewise differential system formed by the linear differential centers (5)


Figure 4. The two limit cycles of the discontinuous piecewise linear differential system formed by the centers (5) and (6).
and (6) has two crossing limit cycles, because the unique real solutions $(p, q)$ of system (1) are $(1,0, \sqrt{2}, 1)$ and $(\sqrt{2},-1, \sqrt{3}, \sqrt{2})$, therefore the intersection points of the two crossing limit cycles with the hyperbola are the pairs $(1,0),(\sqrt{2}, 1)$ and $(\sqrt{2},-1),(\sqrt{3}, \sqrt{2})$. See these two crossing limit cycles in Figure 4.

We will use the following lemma which provides a normal form for an arbitrary linear differential center, for a proof see [13].
Lemma 11. Through a linear change of variables and a rescaling of the independent variable every center in $\mathbb{R}^{2}$ can be written

$$
\begin{equation*}
\dot{x}=-b x-\frac{4 b^{2}+\omega^{2}}{4 a} y+d, \quad \dot{y}=a x+b y+c \tag{7}
\end{equation*}
$$

with $a \neq 0$ and $\omega>0$. This system has the first integral

$$
\begin{equation*}
H_{1}(x, y)=4(a x+b y)^{2}+8 a(c x-d y)+y^{2} \omega^{2} \tag{8}
\end{equation*}
$$

Proof of statement (d) of Theorem 2. In the region $R_{1}$ we consider the arbitrary linear differential center (7) which has first integral (8). In the region $R_{2}$ we consider the arbitrary linear differential center

$$
\begin{equation*}
\dot{x}=-B x-\frac{4 B^{2}+\Omega^{2}}{4 A} y+D, \quad \dot{y}=A x+B y+C \tag{9}
\end{equation*}
$$

with $A \neq 0$ and $\Omega>0$. Which has the first integral

$$
H_{2}(x, y)=4(A x+B y)^{2}+8 A(C x-D y)+y^{2} \Omega^{2}
$$

It is possible to do a rescaling of time in the two above systems. Suppose $\tau=a t$ in $R_{1}$ and $s=A t$ in $R_{2}$. These two rescaling change the velocity in which the orbits of systems (7) and (9) travel, nevertheless they do not change the orbits, therefore they will not change the crossing limit cycles that the discontinuous piecewise linear differential system can have. After these rescalings of the time we can assume without loss of generality that $a=A=1$, and the dot in system (7) (resp. (9)) denotes derivative with respect to the new time $\tau$ (resp. s).

We assume that the discontinuous piecewise linear differential system formed by the two linear differential centers (7) and (9) has three crossing periodic solutions. For this we must impose that the system of equations (1) has three pairs of points as solution, namely $\left(p_{i}, q_{i}\right)$, $i=1,2,3$, since these solutions provide crossing periodic solutions. We consider

$$
\begin{equation*}
p_{i}=\left(\cosh r_{i}, \sinh r_{i}\right) \quad \text { and } \quad q_{i}=\left(\cosh s_{i}, \sinh s_{i}\right), \text { for } i=1,2,3 \tag{10}
\end{equation*}
$$

These points are the points where the three crossing periodic solutions intersect the hyperbola $(\mathrm{H})$. Now we consider that the point $\left(p_{1}, q_{1}\right)$ satisfies system (1) and with this condition we obtain the following expression

$$
\begin{aligned}

This is, we must solve a system with three equations and four unknowns $x_{1}, y_{1}, x_{2}, y_{2}$, that we know that have at least the three solutions (10), so system (13) has a continuum of solutions which produce a continuum of crossing periodic solutions, so such systems cannot have crossing limit cycles. Since in statement ( $c$ ), we have proved that there are systems in $\mathcal{F}_{0}$ with two crossing limit cycles, it follows that the maximum number of crossing limit cycles that intersect $\Sigma$ in two points is two.

This completes the proof of Theorem 2.

## 4. Proof of Theorem 3

In the case where $\Sigma$ is of the type (PL), we have following three regions in the plane: $R_{1}=\left\{(x, y) \in \mathbb{R}^{2}: x<-1\right\}, R_{2}=\left\{(x, y) \in \mathbb{R}^{2}:-1<x<1\right\}$ and $R_{3}=\left\{(x, y) \in \mathbb{R}^{2}: x>\right.$ $1\}$.

We consider a planar discontinuous piecewise differential system separated by two parallel straight lines and formed by three arbitrary linear centers. By Lemma 11, we have that these linear centers can be as follows

We are going to analyze if the discontinuous piecewise linear differential center (14) has crossing periodic solutions. Since the orbits in each region $R_{i}$, for $i=1,2,3$, are ellipses or pieces of one ellipse, we have that if there is a crossing limit cycle this must intersect each straight line $x= \pm 1$ in exactly two points, namely $\left(1, y_{1}\right),\left(1, y_{2}\right)$ and $\left(-1, y_{3}\right),\left(-1, y_{4}\right)$, with
$y_{1}>y_{2}$ and $y_{3}>y_{4}$. Therefore we must study the solutions of the system

We recall that Bézout Theorem states that if a polynomial differential system of equations has finitely many solutions, then the number of its solutions is at most the product of the degrees of the polynomials which appear in the system, see [19]. Then by Bézout Theorem
in this case, we have that system (17) has at most two solutions. Moreover, from these two solutions $\left(y_{2}^{1}, y_{3}^{1}\right)$ and $\left(y_{2}^{2}, y_{3}^{2}\right)$ of (17), we will have two solutions of (16) which are of the form $\left(y_{1}^{1}, y_{2}^{1}, y_{3}^{1}, y_{4}^{1}\right)$ and $\left(y_{1}^{2}, y_{2}^{2}, y_{3}^{2}, y_{4}^{2}\right)$, but analyzing system (16) we have that if $\left(y_{1}^{1}, y_{2}^{1}, y_{3}^{1}, y_{4}^{1}\right)$ is a solution, then $\left(y_{2}^{1}, y_{1}^{1}, y_{4}^{1}, y_{3}^{1}\right)$ is another solution. Finally due to the fact that $y_{1}>y_{2}$ and $y_{3}>y_{4}$, at most one of these two solutions will be satisfactory. Therefore we have proved that the planar discontinuous piecewise differential systems of the family $\mathcal{F}_{1}$, can have at most one crossing limit cycle.

Now we verify that this upper bound is reached, for this we present a discontinuous piecewise linear differential system that belongs to the family $\mathcal{F}_{1}$ and has exactly one crossing limit cycle.

We consider the discontinuous piecewise linear differential centers

differential centers (18) has one crossing limit cycle that intersects (PL) in four points, because the unique real solution ( $y_{1}, y_{2}, y_{3}, y_{4}$ ) with $y_{1}>y_{2}$ and $y_{3}>y_{4}$ of system (15) is the point $\left(y_{1}, y_{2}, y_{3}, y_{4}\right)=(1.5,-1.5,1,-0.5)$. See the crossing limit cycle of this system in Figure 5. This completes the proof of Theorem 3.

## 5. Proof of Theorem 4

We consider a planar discontinuous piecewise linear differential system with four zones separated by (LV) and formed by four arbitrary linear centers. By Lemma 11 this piecewise
linear differential system can be as follows

with $a_{i} \neq 0$ and $\omega_{i}>0$ for $i=1,2,3,4$. The regions $R_{i}$ for $i=1,2,3,4$ are defined just before the statement of Theorem 4. These linear differential centers have the first integrals $H_{1}, H_{2}, H_{3}$ and $H_{4}$ respectively, where

If the discontinuous piecewise linear center (19) has two crossing limit cycles of type 1 , these two crossing limit cycles should be some of Figure 6. We observe that the cases of Figures

$6 \mathrm{~b}, 6 \mathrm{c}$ and 6 d are not possible because in these cases the pieces of the ellipses of linear differential centers in the regions $R_{4}, R_{1}$ and $R_{2}$, respectively would not be nested which contradicts that the linear differential systems in each of these regions are linear centers. Therefore if the discontinuous piecewise linear center (19) has two crossing limit cycles of type 1 these could be as in Figure 6a.

Now we going to study the conditions in order that the piecewise linear differential center (19) has crossing limit cycles of type 1 and we will show that the maximum number of crossing limits cycles of type 1 is one. Without loss of generality we assume that the crossing limit cycles intersect the branches $\Gamma_{1}^{+}$and $\Gamma_{2}^{+}$in the points $\left(0, y_{1}\right),\left(0, y_{2}\right)$ and $\left(x_{1}, 0\right),\left(x_{2}, 0\right)$, respectively, where $0<y_{1}<y_{2}$ and $0<x_{1}<x_{2}$. Then taking into account the first integrals (20) for each linear center, these points must satisfy the following equations

where $l_{1}=4 b_{1}^{2}+\omega_{1}^{2}, l_{2}=4 b_{2}^{2}+\omega_{2}^{2}$ and $\eta=\left(a_{4} c_{1}-a_{1} c_{4}\right)$.
Moreover, by hypothesis $x_{1}<x_{2}$ and $y_{1}<y_{2}$, then from the second and the fourth equations of (21), we have

Doing the Groebner basis of the two polynomials $E_{1}$ and $E_{2}$ with respect to the variables $x_{1}$ and $y_{2}$ we get the two equations

The Bézout Theorem (see [19]) applied to system (22) says that this system has at most two isolated solutions. Therefore system (21) has two solutions which are of the form $\left(x_{1}^{1}, x_{2}^{1}, y_{1}^{1}, y_{2}^{1}\right)$ and $\left(x_{1}^{2}, x_{2}^{2}, y_{1}^{2}, y_{2}^{2}\right)$, but it is possible to prove that if $\left(x_{1}, x_{2}, y_{1}, y_{2}\right)$ is a solution of system (21), then $\left(x_{2}, x_{1}, y_{2}, y_{1}\right)$ is also a solution of this system. Since we must have that $x_{1}<x_{2}$ and $y_{1}<y_{2}$, then system (21) has a unique solution, and therefore the discontinuous piecewise linear differential center (19) that belongs to the family $\mathcal{F}_{2}$ can have at most one crossing limit cycle of type 1 intersecting $\Gamma_{1}^{+}$and $\Gamma_{2}^{+}$.

Now we verify that this upper bound is reached. That is, that there are piecewise linear differential centers in the family $\mathcal{F}_{2}$ having one crossing limit cycle of type 1 . We consider
the following discontinuous piecewise linear differential center

In the region $R_{3}$ we can consider any linear differential center, because the crossing limit cycle will be formed by parts of the orbits of the centers of the regions $R_{1}, R_{2}$ and $R_{4}$. The

centers in (23) have the first integrals

in $R_{i}, i=1,2,3,4$, respectively. Then for the discontinuous piecewise linear differential center (23) system (21) becomes

Taking into account that the solutions $\left(x_{1}, x_{2}, y_{1}, y_{2}\right)$ must satisfy $x_{1}<x_{2}$ and $y_{1}<y_{2}$, we have that the unique solution of system (24) is the point $\left(x_{1}, x_{2}, y_{1}, y_{2}\right)=(1,3,0.5,4)$. See the crossing limit cycle of type 1 of the piecewise linear differential centers (23) in Figure 7. This completes the proof of Theorem 4.

## 6. Proof of Theorem 5

Proof of statement (a) of Theorem 5. In the region $R_{1}$ we consider the linear differential center

In order to have a crossing limit cycle of type 2 , which intersects the discontinuity conic (LV) in four different points $p_{1}=\left(x_{1}, 0\right), q_{1}=\left(0, y_{1}\right), p_{2}=\left(x_{2}, 0\right)$ and $q_{2}=\left(0, y_{2}\right)$, with $x_{1}, y_{1}>0$ and $x_{2}, y_{2}<0$, these points must satisfy the closing equations

Considering the four above linear differential centers (25), (26), (27) and (28) and their respective first integrals $H_{i}(x, y), i=1,2,3,4$, we have the following equivalent system

the unique real solution $\left(p_{1}, q_{1}, p_{2}, q_{2}\right)$ of $(30)$ is $p_{1}=(3,0), q_{1}=(0,2), p_{2}=(-7 / 2,0)$ and $q_{2}=(0,-4)$, therefore the piecewise differential system formed by the linear differential centers (25), (26), (27) and (28) has exactly one crossing limit cycle of type 2 . See the crossing limit cycle of this system in Figure 8.

Proof of statement (b) of Theorem 5. In the region $R_{1}$ we consider the linear differential center

which has the first integral $H_{1}(x, y)=x(7+4 x)-7 y / 3+4 x y+2 y^{2}$. In the region $R_{2}$ we consider the linear differential center

\end{equation*}

this system has the first integral $H_{2}(x, y)=\left(200 x^{2}+y(251+218 y)+x(-586+400 y)\right) / 50$. In the region $R_{3}$ we have the linear differential center

this system has the first integral $H_{3}(x, y)=4 x^{2}+x(23 / 3-2 y)+5 y(-1+3 y) / 12$. In the region $R_{4}$ we have the linear differential center

this system has the first integral $H_{4}(x, y)=\left(144 x^{2}-6 x(53+16 y)+y(137+25 y)\right) / 36$. This discontinuous piecewise differential system formed by the linear differential centers (31), (32), (33) and (34) has two crossing limit cycles of type 2 , because the unique real solutions $\left(p_{1}^{i}, q_{1}^{i}, p_{2}^{i}, q_{2}^{i}\right)$, with $i=1,2$ of system (29) are $p_{1}^{1}=(1,0), q_{1}^{1}=(0,3), p_{2}^{1}=(-5 / 2,0)$ and $q_{2}^{1}=(0,-2)$ and $p_{1}^{2}=(2,0), q_{1}^{2}=(0,9 / 2), p_{2}^{2}=(-4,0)$ and $q_{2}^{2}=(0,-5)$. See these two crossing limit cycles in Figure 9.

Proof of statement (c) of Theorem 5. In the region $R_{1}$ we consider the linear differential center

this system has the first integral $H_{3}(x, y)=4 x^{2}+x(15-16 y / 3)+y(219+47 y) / 20$. In the region $R_{4}$ we have the linear differential center

\dot{x}=-\frac{7}{10}-\frac{x}{4}-\frac{y}{5}, \quad \dot{y}=-\frac{3}{2}+x+\frac{y}{4}, \tag{38}
\end{equation*}
$$

this system has the first integral $H_{4}(x, y)=4 x^{2}+2 x(-6+y)+4 y(7+y) / 5$. This discontinuous piecewise differential system formed by the linear differential centers (35), (36), (37) and (38) has three crossing limit cycles of type 2, because the unique real solutions $\left(p_{1}^{i}, q_{1}^{i}, p_{2}^{i}, q_{2}^{i}\right)$, with $i=1,2,3$ of system (29) are $p_{1}^{1}=(1,0), q_{1}^{1}=(0,3), p_{2}^{1}=(-5 / 2,0)$ and $q_{2}^{1}=(0,-2) ; p_{1}^{2}=(2,0), q_{1}^{2}=(0,9 / 2), p_{2}^{2}=(-4,0)$ and $q_{2}^{2}=(0,-5) ;$ and $p_{1}^{3}=(3,0)$, $q_{1}^{3}=(0,6), p_{2}^{3}=(-11 / 2,0)$ and $q_{2}^{3}=(0,-7)$. See these three crossing limit cycles of type 2 in Figure 10.

## 7. Proof of Theorem 6

If the discontinuity curve $\Sigma$ is of the type (P), we have following two regions in the plane: $R_{1}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}<y\right\}$, and $R_{2}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}>y\right\}$.

We consider a planar discontinuous piecewise linear differential system formed by two linear arbitrary centers. By Lemma 11 these piecewise linear differential centers can be as follows

These linear differential centers have the first integrals

respectively. After two rescalings of time as in the proof Theorem 2 we can assume without loss of generality that $a=\alpha=1$.

In order that the piecewise linear differential centers (39) has crossing limit cycles with four point on $(\mathrm{P})$. We must study the solutions of the system:

We assume that the discontinuous piecewise linear differential centers (39) has two crossing periodic solutions. For this we must have that system of equations (42) has two real solutions, namely $\left(p_{1}, p_{2}, p_{3}, p_{4}\right)$ and $\left(q_{1}, q_{2}, q_{3}, q_{4}\right)$, where $p_{i}=\left(k_{i}, k_{i}^{2}\right)$ and $q_{i}=\left(L_{i}, L_{i}^{2}\right)$, with $i=1,2,3,4$. These points are the points where the two crossing periodic solution intersect discontinuity curve ( P ).

If the point $\left(p_{1}, p_{2}, p_{3}, p_{4}\right)$ satisfies system (42), by the equation $e_{1}$ of (42) we obtain the following expression

which is a contradiction because by hypothesis each of the linear differential systems considered is a center. Therefore we have proved that the maximum number of crossing limit cycles of the discontinuous piecewise linear differential centers in $\mathcal{F}_{3}$ is one.

Now we verify that this upper bound is reached. That is, that there are piecewise linear differential centers in the family $\mathcal{F}_{3}$ having one crossing limit cycle. We consider the discontinuous piecewise linear differential system formed by the following linear differential centers

tial centers (43) and (44) has one crossing limit cycle, because the unique real solution $\left(p_{1}, p_{2}, p_{3}, p_{4}\right)$ of system (42) is $p_{1}=(4,16), p_{2}=(-13 / 5,169 / 25), p_{3}=(-3 / 2,9 / 4)$, and $p_{4}=(2,4)$. See the crossing limit cycle of this system in Figure 11.

## 8. Proof of Theorem 7

When the discontinuity curve $\Sigma$ is of the type (E), we have following two regions in the plane: $R_{1}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}+y^{2}<1\right\}$, and $R_{2}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}+y^{2}>1\right\}$. By Lemma 11 a piecewise linear differential center of family $\mathcal{F}_{4}$ can be consider as (39) where the first integrals are given in (40).

Now we going to study the conditions in order that a piecewise linear differential center in the family $\mathcal{F}_{4}$ has crossing limit cycles intersecting the discontinuity curve (E) in exactly four points. Taking into account the first integrals (40) a piecewise linear differential center in $\mathcal{F}_{4}$ has crossing limit cycles if there are points $\left(x_{i}, y_{i}\right)$ for $i=1,2,3,4$ satisfying the equations

Where we consider without generality $a=\alpha=1$ as in the proof Theorem 2 .
We assume that this piecewise linear differential center has two crossing periodic solutions. For this we have that system (45) has two pairs of solutions, $\left(p_{1}, p_{2}, p_{3}, p_{4}\right)$ and $\left(q_{1}, q_{2}, q_{3}, q_{4}\right)$ with $p_{i} \neq p_{j}$, and $q_{i} \neq q_{j}$, for $i \neq j$ and $i, j=1,2,3,4$. Since these solution points are on the circle ( E ), then we can consider them in the following way

Analogously, substituting the second solution $\left(q_{1}, q_{2}, q_{3}, q_{4}\right)$ with $q_{i}$ as in (46) in (45) we get remaining parameters $\omega, \Omega, b, \beta$. Substituting $k_{i}, \lambda_{i}, m_{i}, n_{i}$ like (46) we obtain that $b=\beta=0$, therefore we get that the piecewise linear differential centers is formed by linear differential center $\dot{x}=-y, \quad \dot{y}=x$, in the regions $R_{1}$ and $R_{2}$. This is a contradiction because with this linear differential center is not possible to generate crossing limit cycles. Then we proved that the maximum number of crossing limits cycles for piecewise linear differential centers in $\mathcal{F}_{4}$ is one. Moreover this maximum number is reached, that is, there are piecewise linear differential centers in $\mathcal{F}_{4}$ such that have one crossing limit cycle with four points on (E), as we see below

Consider the discontinuous piecewise linear differential centers in the family $\mathcal{F}_{4}$ formed by the following two linear differential centers

See the crossing limit cycle of this system in Figure 12.

## 9. Proof of Theorem 8

If the discontinuity curve $\Sigma$ is of the type $(\mathrm{H})$ we have following three regions in the plane: $R_{1}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}-y^{2}>1, x>0\right\}, R_{2}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}-y^{2}<1\right\}$ and $R_{3}=\left\{(x, y) \in \mathbb{R}^{2}: x^{2}-y^{2}>1, x<0\right\}$.

We consider a planar discontinuous piecewise linear differential system formed by three linear arbitrary centers. By Lemma 11 these linear differential centers can be as follows

In order to have a crossing limit cycle, which intersects the discontinuity curve $(H)$ in four different points $p_{i}=\left(x_{i}, y_{i}\right), i=1,2,3,4$, these points must satisfy the following equations

We assume that the discontinuous piecewise linear differential system formed by the three linear differential centers in (49) has two crossing periodic solutions. For this we must impose that the system of equations (52) has two of real solution, namely ( $p_{1}, p_{2}, p_{3}, p_{4}$ ) and $\left(q_{1}, q_{2}, q_{3}, q_{4}\right)$. Since these solutions provide crossing periodic solutions and these points are the points where the crossing periodic solutions intersect the hyperbola $(\mathrm{H})$ we can consider

Finally by the fourth equation in (52) we have that $b_{2}=0$. With these expressions for $d_{2}, c_{2}, \omega_{2}$ and $b_{2}$ we obtain that the linear differential system in the region $R_{2}$ is $\dot{x}=y, \dot{y}=x$, which is a linear differential system type saddle. This is a contradiction because we are working with centers in each region $R_{i}$ for $i=1,2,3$. Therefore we have proved that the maximum number of crossing limit cycles for systems in $\mathcal{F}_{5}$ is one.

Moreover it is possible to show that there are piecewise linear differential centers in $\mathcal{F}_{5}$ such that have one crossing limit cycle. Indeed, consider the discontinuous piecewise linear differential system in the family $\mathcal{F}_{5}$ formed by the following linear differential centers

## 10. Proof of Theorem 9

Proof of statement (a) of Theorem 9. In this case we use the notations given in the proof of Theorem 6, then we consider the planar discontinuous piecewise linear center (39) and the first integrals (40). In order that the discontinuous piecewise linear center (39) has crossing limit cycles with four points, namely $\left(x_{1}, x_{1}^{2}\right),\left(x_{2}, x_{2}^{2}\right),\left(x_{3}, x_{3}^{2}\right),\left(x_{4}, x_{4}^{2}\right)$ and one crossing limit cycle with two points, namely $\left(x_{5}, x_{5}^{2}\right),\left(x_{6}, x_{6}^{2}\right)$ on ( P ), we must study the solutions $\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}, x_{6}\right)$ of system (41) and the equations

We assume that systems (42) and (57) have two real solutions where each real solution provides one crossing limit cycle with four points on ( P ) and one crossing limit cycle whit two
points on (P), but by Theorem 6 we have that discontinuous piecewise linear center (39) has at most 1 crossing limit cycle with four points on $(\mathrm{P})$, therefore if we have two real solutions of systems (42) and (57) they are of the form $\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}, x_{6}\right)=\left(k_{1}, k_{2}, k_{3}, k_{4}, k_{5}, k_{6}\right)$ and $\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}, x_{6}\right)=\left(k_{1}, k_{2}, k_{3}, k_{4}, \lambda_{5}, \lambda_{6}\right)$, with $k_{i}, \lambda_{5}, \lambda_{6} \in \mathbb{R}$ for $i=1,2,3,4,5,6$.

If the point ( $k_{1}, k_{2}, k_{3}, k_{4}, k_{5}, k_{6}$ ) satisfies systems (42) and (57), by the equations $e_{1}, e_{2}, e_{3}$ and $e_{4}$ of (42) we obtain expressions for the parameters $d, \delta, c$ and $\gamma$ as in the proof of Theorem 6, by the equation $e_{5}$ of system (57) we obtain an expression for $\omega^{2}=S / T$ with $S$ and $T$ as in the proof of Theorem 6 changing $L_{1}$ and $L_{2}$ by $k_{5}$ and $k_{6}$, respectively. By equation $e_{6}$ of system (57) we obtain $\Omega^{2}=V / W$ where the expression for $V$ and $W$ are the same expressions that in the proof of Theorem 6 changing $L_{3}$ by $k_{5}$. We assume that the point ( $k_{1}, k_{2}, k_{3}, k_{4}, \lambda_{5}, \lambda_{6}$ ) satisfies systems (42) and (57), then we have $e_{1}=e_{2}=e_{3}=$ $e_{4}=0$ and by the equations $e_{5}$ and $e_{6}$ of system (57) we obtain $b=\beta=0$. As in the proof of Theorem 6 we can conclude that the two linear centers in (39) became $\dot{x}=1 / 2, \quad \dot{y}=x$, which is a contradiction. So systems (42) and (57) have at most one solution and therefore planar discontinuous piecewise linear centers in $\mathcal{F}_{3}$ have at most one crossing limit cycle with four point on $(\mathrm{P})$ and one crossing limit cycle with two points on $(\mathrm{P})$ simultaneously. Moreover this upper bound is reached, this is there are systems in $\mathcal{F}_{3}$ with one crossing limit cycle with four points on (P) and one crossing limit cycle with two points on (P) simultaneously.

See these crossing limit cycles in Figure 14.

Proof of statement (b) of Theorem 9. In this case we consider the notations of the proof of Theorem 7 and therefore we consider the planar discontinuous piecewise linear center (39) and the first integrals (40). In order that the discontinuous piecewise linear center (39) has crossing limit cycles with four points on (E), namely $\left(x_{1}, y_{1}\right),\left(x_{2}, y_{2}\right),\left(x_{3}, y_{3}\right),\left(x_{4}, y_{4}\right)$ and one crossing limit cycle with two points on (E), namely $\left(x_{5}, y_{5}\right),\left(x_{6}, y_{6}\right)$, we must study the solutions ( $p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}$ ) of systems (45) and (60)

e_{5}=4\left(x_{5}^{2}-x_{6}^{2}\right)+8\left(c\left(x_{5}-x_{6}\right)-d y_{5}+b x_{5} y_{5}+d y_{6}-b x_{6} y_{6}\right)+\left(y_{5}^{2}-y_{6}^{2}\right) l_{1}=0 \\
e_{6}=4\left(x_{6}^{2}-x_{5}^{2}\right)+8\left(\beta x_{6} y_{6}-\beta x_{5} y_{5}+y_{5} \delta-x_{5} \gamma+x_{6} \gamma-y_{6} \delta\right)+\left(y_{6}^{2}-y_{5}^{2}\right) l_{2}=0  \tag{60}\\
E_{5}=x_{5}^{2}+y_{5}^{2}-1=0 \\
E_{6}=x_{6}^{2}+y_{6}^{2}-1=0
\end{array}
$$

We assume that systems (45) and (60) have two real solutions where each real solution provides one crossing limit cycle with four points on (E) and one crossing limit cycle with two points on (E), like in Theorem 7 we proved that discontinuous piecewise linear center (39) has at most 1 crossing limit cycle with four points on (E), then we have that if there are two real solutions of systems (45) and (60) they are of the form ( $p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}$ ) and $\left(p_{1}, p_{2}, p_{3}, p_{4}, q_{5}, q_{6}\right)$, with $p_{i}$ and $q_{j}$ as (46) for $i=1,2,3,4,5,6$ and $j=5,6$.

Substituting the first solution $\left(p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}\right)$ in systems (45) and (60) we obtain from the equations $e_{1}, e_{2}, e_{3}$ and $e_{4}$ of (45) the same expressions than in the proof of Theorem 7 for $d, \delta, c, \gamma$, and by the equations $e_{5}$ and $e_{6}$ of system (60) we obtain the same expressions than in the proof of Theorem 7 for $\omega$ and $\Omega$ changing $\left(m_{1}, n_{1}\right)$ by $\left(k_{5}, \lambda_{5}\right)$ and $\left(m_{2}, n_{2}\right)$ by $\left(k_{6}, \lambda_{6}\right)$, respectively. We assume that the point $\left(p_{1}, p_{2}, p_{3}, p_{4}, q_{5}, q_{6}\right)$ satisfies systems (45) and (60), then we have $e_{1}=e_{2}=e_{3}=e_{4}=0$ and by the equations $e_{5}$ and $e_{6}$ of system (60) we obtain $b=\beta=0$. As in the proof of Theorem 7 we obtain that both linear centers in (39) become $\dot{x}=-y, \dot{y}=x$, in contradiction that they have limit cycles. So we can conclude that systems (45) and (60) have at most one solution and therefore planar discontinuous piecewise linear centers in $\mathcal{F}_{4}$ have at most one crossing limit cycle with four points on (E) and one crossing limit cycle with two points on (E) simultaneously.

Now we verify that this upper bound is reached, that is there are systems in $\mathcal{F}_{4}$ with one crossing limit cycle with four points on (E) and one crossing limit cycle with two points on (E) simultaneously. We consider the discontinuous piecewise linear differential system in $\mathcal{F}_{4}$ formed by the linear centers
(61)
$\dot{x}=\frac{3 \sqrt{2}+\sqrt{6}-6}{4(2 \sqrt{2}+3 \sqrt{3}-3)}-\frac{x}{2}-\frac{2(\sqrt{2}+\sqrt{3}-2)}{2 \sqrt{2}+3 \sqrt{3}-3} y, \dot{y}=\frac{3 \sqrt{2}+2 \sqrt{3}+\sqrt{6}-4}{4(2 \sqrt{2}+3 \sqrt{3}-3)}+x+\frac{y}{2}$, in $R_{1}$,
$\dot{x}=\frac{18-93 \sqrt{2}+4 \sqrt{3}+33 \sqrt{6}}{920(1+\sqrt{3})}-\frac{x}{4}+\frac{31 \sqrt{2}+37 \sqrt{3}-11 \sqrt{6}-236}{230} y$,
$\dot{y}=\frac{89 \sqrt{2}+58 \sqrt{3}+7 \sqrt{6} 192}{920(1+\sqrt{3})}+x+\frac{y}{4}, \quad$ in $R_{2}$.
The unique real solution of systems (45) and (60) in this case is $\left(p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}\right)$ with $p_{1}=(\cos \pi / 2, \sin \pi / 2), p_{2}=(\cos \pi, \sin \pi), \quad p_{3}=(\cos 3 \pi / 2, \sin 3 \pi / 2), p_{4}=(\cos -\pi / 3$, $\sin -\pi / 3), p_{5}=(\cos \pi / 4, \sin \pi / 4)$ and $p_{6}=(\cos 0, \sin 0)$. See these crossing limit cycles in Figure 15.

Proof of statement (c) of Theorem 9. Here we consider the notations of the proof of Theorem 8 and therefore we consider the planar discontinuous piecewise linear center (49) and the first integrals (50). In order that the discontinuous piecewise linear center (49) has

crossing limit cycles with four points on (H), namely $\left(x_{1}, y_{1}\right),\left(x_{2}, y_{2}\right),\left(x_{3}, y_{3}\right),\left(x_{4}, y_{4}\right)$ and one crossing limit cycle with two points on (H), namely $\left(x_{5}, y_{5}\right),\left(x_{6}, y_{6}\right)$, we must study the solutions ( $p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}$ ) of systems (52) and (63)

e_{6}=4\left(x_{6}^{2}-x_{5}^{2}\right)+8\left(b_{1} x_{6} y_{6}-b_{1} x_{5} y_{5}+y_{5} d_{1}-x_{5} c_{1}+x_{6} c_{1}-y_{6} d_{1}\right)+\left(y_{6}^{2}-y_{5}^{2}\right) l_{2}= & 0, \\
E_{5}=x_{5}^{2}-y_{5}^{2}-1 & =0, \\
E_{6}=x_{6}^{2}-y_{6}^{2}-1 & =0 .
\end{align*}
$$

We assume that systems (52) and (63) have two real solutions where each real solution provides one crossing limit cycle with four points on (H) and one crossing limit cycle with two points on (H). By Theorem 8 the discontinuous piecewise linear center (49) has at most 1 crossing limit cycle with four points on $(\mathrm{H})$, then we have that if there are two real solutions of systems (52) and (63) they are of the form ( $p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}$ ) and ( $p_{1}, p_{2}, p_{3}, p_{4}, q_{5}, q_{6}$ ), with $p_{i}$ and $q_{j}$ as (53) for $i=1,2,3,4,5,6$ and $j=5,6$.

Considering the first solution ( $p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}$ ) of systems (52) and (63) we obtain the same expressions that in the proof of Theorem 8 for $d_{1}, d_{2}, d_{3}, c_{2}, c_{1}, \omega_{2}$ changing ( $m_{1}, n_{1}$ ) by $\left(k_{5}, \lambda_{5}\right)$ and ( $m_{2}, n_{2}$ ) by ( $k_{6}, \lambda_{6}$ ), respectively.

Now we assume that the point ( $p_{1}, p_{2}, p_{3}, p_{4}, q_{5}, q_{6}$ ) satisfies systems (52) and (63), then we have $e_{1}=e_{2}=e_{3}=e_{4}=0$, and by the equation $e_{5}$ of system (63) we obtain $b_{2}=0$ and with this the linear system in the region $R_{2}$ becomes a saddle which is a contradiction, because we are working with linear centers in each regions $R_{i}$ for $i=1,2,3$. Therefore the discontinuous piecewise linear center (49) has at most one crossing limit cycle with four points on (H) and one crossing limit cycle with two points on (H) simultaneously. Moreover this upper bound is reached, that is there are piecewise linear differential centers in $\mathcal{F}_{5}$ such that have one crossing limit cycle with four points on (H) and one crossing limit cycle with two points on (H) simultaneously. Indeed consider the piecewise linear differential system
formed by the linear centers

\dot{x}=\frac{-1215-576 \sqrt{2}+256 \sqrt{7}+112 \sqrt{13}-384 \sqrt{15}}{192(2 \sqrt{7}+\sqrt{13}-\sqrt{\alpha})}-\frac{x}{2}-\frac{29}{16} y

\dot{y}= & \frac{-1}{48\left(-1+2 \sqrt{\frac{7}{\alpha}}+\sqrt{\frac{13}{\alpha}}\right)}\left(-\frac{675}{4}-64 \sqrt{7}-28 \sqrt{13}+288 \sqrt{\frac{2}{7}(23-4 \sqrt{30})}\right. \\
& \left.+945 \sqrt{\frac{7}{\alpha}}+\frac{945}{2} \sqrt{\frac{13}{\alpha}}+144 \sqrt{\frac{26}{\alpha}}+192 \sqrt{\frac{105}{\alpha}}+96 \sqrt{\frac{195}{\alpha}}\right)+x+\frac{y}{2}, \text { in } R_{1}, \\
\dot{x}= & \frac{1125+432 \sqrt{14}+189 \sqrt{26}+207 \sqrt{30}+160 \sqrt{105}+70 \sqrt{195}}{6 \xi}-\frac{x}{2} \\
(65) & -\frac{54 \sqrt{2}+336 \sqrt{7}+174 \sqrt{13}+24 \sqrt{15}+68 \sqrt{210}+35 \sqrt{390}-\eta}{\eta} y, \\
\dot{y}= & -\frac{855 \sqrt{2}+3516 \sqrt{7}+1797 \sqrt{13}+315 \sqrt{15}+644 \sqrt{210}+329 \sqrt{390}}{6 \xi}+x+\frac{y}{2}, \text { in } R_{2},
\end{aligned}

here $\alpha=23+4 \sqrt{30}, \eta=42+48 \sqrt{14}+24 \sqrt{26}+9 \sqrt{30}+24 \sqrt{105}+12 \sqrt{195}$ and $\xi=$ $87+108 \sqrt{14}+54 \sqrt{26}+16 \sqrt{30}+40 \sqrt{105}+20 \sqrt{195}$. The unique real solution of systems (51) and (63) in this case is $\left(p_{1}, p_{2}, p_{3}, p_{4}, p_{5}, p_{6}\right)$ with $p_{1}=(3,-\sqrt{8}), p_{2}=(4, \sqrt{15}), p_{3}=$ $(-3, \sqrt{8}), p_{4}=(-1,0), p_{5}=(7 / 6,-\sqrt{13} / 6)$ and $p_{6}=(4 / 3, \sqrt{7} / 3)$. See these crossing limit cycles in Figure 16.

## 11. Proof of Theorem 10

Proof of statement (a) of Theorem 10. In the region $R_{1}$ we consider the linear differential center

\dot{x}=-\frac{193}{134}-\frac{x}{3}-\frac{58}{67} y, \quad \dot{y}=-\frac{149}{134}+x+\frac{y}{3} \tag{67}
\end{equation*}

this system has the first integral $\left.H_{1}(x, y)=201 x^{2}+x(134 y-447)+3 y(58 y-193)\right)$. In the region $R_{2}$ we have the linear differential center

$$
\begin{equation*}
\dot{x}=-\frac{153}{16}-\frac{x}{2}-\frac{17}{4} y, \quad \dot{y}=-\frac{89}{32}+x+\frac{y}{2} \tag{68}
\end{equation*}
$$

which has the first integral $H_{2}(x, y)=4 x^{2}+17 y(2 y-9) / 2+x(4 y-89 / 4)$. In the region $R_{3}$ we have the linear differential center

$$
\begin{equation*}
\dot{x}=-\frac{43}{40}-\frac{\sqrt{3}}{4} x-\frac{3}{4} y, \quad \dot{y}=1+x-\frac{\sqrt{3}}{4} y \tag{69}
\end{equation*}
$$

which has the first integral $H_{3}(x, y)=4 x(2+x)+43 / 5 y-2 \sqrt{3} x y+3 y^{2}$. And in the region $R_{4}$ we have the linear differential center

$$
\begin{equation*}
\dot{x}=\frac{251}{512}-\frac{y}{256}, \quad \dot{y}=-2+x \tag{70}
\end{equation*}
$$

which has the first integral $H_{4}(x, y)=4 x(x-4)+y(y-251) / 64$.
In order to have a crossing limit cycle of type 1 and one crossing limit cycle of type 2 , we must study the real solutions $\left(p_{1}, q_{1}, p_{2}, q_{2}, p_{3}, q_{3}, p_{4}, q_{4}\right)$, of systems (21) and (29) respectively, where $p_{i}=\left(x_{i}, 0\right)$ and $q_{i}=\left(0, y_{i}\right)$, with $x_{1}, x_{2}, x_{3}, y_{1}, y_{2}, y_{3}>0$ and $x_{4}, y_{4}<0$.

In this case considering the four above centers (67), (68), (69) and (70) and their respective first integrals we have that the unique real solution for systems (21) and (29) is $\left(p_{1}, q_{1}, p_{2}, q_{2}, p_{3}, q_{3}, p_{4}, q_{4}\right)$ with $p_{1}=(1,0), q_{1}=(0,1 / 2), p_{2}=(3,0), q_{2}=(0,4), p_{3}=(5,0)$, $q_{3}=(0,6), p_{4}=(-4,0)$ and $q_{4}=(0,-5)$. See these crossing limit cycles of types 1 and 2 in Figure 17.

Proof of statement (b) of Theorem 10. In the region $R_{1}$ we consider the linear differential center

$$
\begin{equation*}
\dot{x}=\frac{193}{134}-\frac{x}{3}-\frac{58}{67} y, \quad \dot{y}=-\frac{149}{134}+x+\frac{y}{3} \tag{71}
\end{equation*}
$$

this system has the first integral $\left.H_{1}(x, y)=201 x^{2}+x(134 y-447)+3 y(58 y-193)\right)$. In the region $R_{2}$ we have the linear differential center

$$
\begin{equation*}
\dot{x}=\frac{9}{2}-\frac{x}{2}-2 y, \quad \dot{y}=-\frac{1}{4}+x+\frac{y}{2} \tag{72}
\end{equation*}
$$

which has the first integral $H_{2}(x, y)=2 x(4 x-1)+4 y(x-9)+8 y^{2}$. In the region $R_{3}$ we have the linear differential center

$$
\begin{equation*}
\dot{x}=-\frac{11}{8}+\frac{\sqrt{3}}{4} x-\frac{3}{4} y, \quad \dot{y}=\frac{11}{8}+x-\frac{\sqrt{3}}{4} y \tag{73}
\end{equation*}
$$

which has the first integral $H_{3}(x, y)=4 x^{2}+y(11+3 y)+x(11-2 \sqrt{3} y)$. And in the region $R_{4}$ we have the linear differential center

$$
\begin{equation*}
\dot{x}=\frac{51831-595 \sqrt{16909}}{35912}+\frac{x}{2}+\frac{6775-119 \sqrt{16909}}{17956} y, \quad \dot{y}=-2+x-\frac{y}{2} \tag{74}
\end{equation*}
$$

which has the first integral $H_{4}(x, y)=17956\left(x^{2}-x(4+y)\right)+y(595 \sqrt{16909}-51831+$ $(118 \sqrt{16909}-6775) y)$. The unique real solutions for systems (21) and (29) are ( $p_{1}, q_{1}, p_{2}, q_{2}, p_{3}, q_{3}, p_{4}, q_{4}$ )

with $p_{1}=(1,0), q_{1}=(0,1 / 2), p_{2}=(3,0), q_{2}=(0,4), p_{3}=(5,0), q_{3}=(0,6), p_{4}=(-4,0)$ and $q_{4}=(0,-5)$. And $\left(p_{1}, q_{1}, p_{2}, q_{2}, l_{3}, m_{3}, l_{4}, m_{4}\right)$ with $l_{3}=((149+3 \sqrt{16909}) / 134,0)$, $m_{3}=(0,5), l_{4}=(-2,0)$ and $m_{4}=(0,-3)$. See these crossing limit cycles of types 1 and 2 in Figure 18.
